## European Parliament Decision of 12 July 1995 appointing the Ombudsman of the European Union (95/376/EC, Euratom, ECSC)

THE EUROPEAN PARLIAMENT,

— having regard to the Treaty establishing the European Community, and in particular Articles 8d, second paragraph, and 138e thereof,

— having regard to the Treaty establishing the European Coal and Steel Community, and in particular Article 20d thereof,

— having regard to the Treaty establishing the European Atomic Energy Community, and in particular Article 107d thereof,

— having regard to its decision of 9 March 1994 on the regulations and general conditions governing the performance of the Ombudsman's duties <sup>(1)</sup>,

— having regard to Rule 159 of its Rules of Procedure,

— having regard to the calls for nominations of 30 July 1994 <sup>(2)</sup> and 23 May 1995 <sup>(3)</sup>,

— having regard to the nominations forwarded pursuant to Article 6 (2) of the regulations and general conditions governing the performance of the Ombudsman's duties and Rule 159(3) of Parliament's Rules of Procedure,

— having regard to the hearings of the nominees in the committee responsible,

— having regard to the list of admissible nominations,

— having regard to its votes of 11 and 12 July 1995,

appoints Mr Jacob Magnus Söderman Ombudsman of the European Union.
