

## Letter from Jacques Camille Paris to E. Star Busmann (Strasbourg, 4 April 1952)

**Caption:** In a letter dated 4 April 1952, the Secretary General of the Council of Europe informs the Secretary-General of the Brussels Treaty Organisation (Western Union) that the Committee of Ministers has adopted a Resolution, attached to the letter, approving the proposals on cooperation between the two organisations contained in the letter of 15 November 1951.

## Letter from the Secretary-General of the Council of Europe to the Secretary-General of the Brussels Treaty Organisation (Strasbourg, 4 April 1952)

Sir,

The Committee of Ministers of the Council of Europe at its Tenth Session considered the letter which you addressed to me on 15th November, 1951 on the subject of relations between the Council of Europe and the Brussels Treaty Organisation.

At the conclusion of its discussion, the Committee of Ministers adopted a resolution the text of which is attached hereto.

In accordance with the terms of this Resolution, the committee of Ministers has instructed me to approach you with a view to the implementation of the proposals contained in your letter. I should be grateful if you would inform me of any suggestions which you may have on this subject.

On our side, I have made the necessary arrangements in order that the departments of the Secretariat-General of the Council of Europe should discharge the undertakings resulting from the proposals contained in your letter.

Furthermore, the resolution of the Committee of Ministers will be communicated to the Consultative Assembly and I shall not fail to inform you of any conclusions which the Assembly may reach on this subject.

#### **Resolution No. 5 (adopted by the Committee of Ministers on 19 March 1952)**

#### **Relations between the Council of Europe and the Brussels Treaty Organisation**

The Committee of Ministers,

Having further regard to Recommendation (50) 19 of the Consultative Assembly relating to the incorporation into the Council of Europe of certain organs of the Consultative Council of the Brussels

Treaty ;

Having regard to its Resolution of 2nd May, 1951, in which the Committee of Ministers decided to transmit this Recommendation to the five signatory Powers of the Brussels Treaty ;

Having regard to the letter of 15th November, 1951 from the Secretary-General of the Brussels Treaty Organisation to the Secretary-General of the Council of Europe ;

1. Approves the proposals contained in this letter ;
2. Instructs the Secretary-General of the Council of Europe to get into touch with the Secretary-General of the Brussels Treaty Organisation with a view to putting these proposals into effect.
