Brussels Treaty Organization (B.T.O.)

On 17/04/1948 during the 1st meeting of the Brussels Treaty Permanent Commission, representatives agreed that Chairmanship rotate every three months, following alphabetical order, beginning with the U.K. Chairmanship was handed over during meetings until March 1950. In the same period, the Chairmanship of meetings of the Consultative Council of the Brussels Treaty (Ministerial Level) was decided on a case- by-case basis by Ministers.

On 2nd October 1952 (158th meeting of the P.C) it was agreed that the Chairmanship of the P.C. should change every six months. The Netherlands began the first 6-month Chairmanship in Nov 1952.

On 09/11/1954 (180th meeting) the P.C. decided that when the French Delegation's term of office ended, the Chairmanship should pass to the Luxembourg Delegation, thus taking their turn under the established system with other Delegations following in alphabetical order. It was further decided to return to the system of a three-monthly chairmanship period.
