A further strong point of the project is the large number of interviews recorded by the CVCE with Luxembourg and European figures who share their memories and thoughts concerning Pierre Werner, his achievements and his views on the European integration process. These interviews represent entirely new sources, not only for the CVCE but more broadly for the research community.
