- * Declaration concerning Denmark's ratification of the Treaty of 2 March 2012 on Stability, Coordination and Governance in the Economic and Monetary Union: With reference to Article 14(5) of the Treaty, Denmark declares that it will be bound by all the provisions of Titles III and IV thereof the content of which is applicable, wholly or partly, to those Contracting Parties which do not have the euro as currency, from the time of Danish ratification but not before the entry into force of the Treaty. As a consequence of its obligations with regard to the Treaty, Denmark will not be bound by any EU legislative rules which result from subsequent implementation of Titles III and IV of the Treaty and are adopted on the basis of provisions of the Treaties on the European Union which are applicable only to those Member States which have the euro as their currency.
- ** According to article 14 paragraph (5) of the Treaty, Romania declares its intention to apply all the provisions of Title III and IV of the Treaty, as of 1 January 2013, provided that twelve Contracting Parties whose currency is the euro have deposited their instrument of ratification, or on the first day of the month following the deposit of the twelfth instrument of ratification by a Contracting Party whose currency is the euro, whichever is the earlier
