# Draft reply by the French delegation to the WEU Council to written question 93 (London, 23 June 1965)

**Caption:** In a note dated 23 June 1965, the Secretary-General of Western European Union (WEU) circulates question 93 put by German Assembly member Georg Kliesing (see document WPM(481)) and the draft reply by the French delegation to the WEU Council to this question. Further to written question 80 of 14th February 1965 concerning Franco-British collaboration on the development of a light strike and trainer aircraft, will the Council, now the agreement has been concluded on 17th May 1965, inform the Assembly whether adherence of other member States to the agreement would be possible and, if so, under what conditions?

If it is true that some 1,000 light strike and trainer aircraft will be needed in the whole of Western Europe, will not common development and production be advisable?

Will the Council promote this co-operation?
