Reply by the Council

The Anglo-French project for the development of a variable-geometry aircraft was a subject of a joint statement by the two Governments to the Standing Armaments Committee on 4th June 1965 and of a discussion in the Committee on 9th September the same year.

The French and British Governments have decided to pursue jointly the preliminary studies on this project. It would therefore be appropriate if any government, which may be in any way interested in this project, should approach, in the first instance, either the British or the French Governments. In principle the two Governments are prepared to consider industrial participation by other countries, including members of W.E.U.
