Draft reply by the WEU Council to question 160 put by a member of the Assembly on nuclear forces (London, 18 September 1975)

Caption: On 18 September 1975, the Council of Western European Union (WEU) circulates a draft reply to question 160 put by Mr Krieg, a member of the Assembly. The member had asked if the nuclear forces of two WEU member countries — France and the United Kingdom — are capable of playing a role in a western defence system based on selective nuclear retaliation. The draft reply, drawn up following the discussions that took place at the Council meeting on 17 September 1975, includes the original proposal by Britain and France (WPM(75)24) as well as a series of amendments proposed by other delegations. Opinions differ on the paragraph concerning the Declaration on Atlantic Relations signed in Ottawa, which the French and British see as explicitly recognising the deterrent role played by the two countries in the overall strengthening of the deterrence of the Alliance.

Do the Council consider that the nuclear forces of two W.E.U. member countries are capable of playing a role in a western defence system based on selective nuclear retaliation?

Draft reply to written question 160 based on discussion at the meeting of the Council on 17th September, 1975
(C (75) 100; CR (75) 11, IV, 1)

First paragraph

Any nuclear force could be assigned to and play a role in a defence system which had a selective targeting doctrine. Whether any nation's force is in the event so assigned is a matter for political decision. The United Kingdom's nuclear forces are assigned to NATO. Those of France, the other W.E.U. member which is a nuclear power, are not.

Second paragraph

Moreover, paragraph 6 of the Declaration on Atlantic Relations, approved on 19th June, 1974, at Ottawa by the North Atlantic Council, recognised explicitly that two of the European members "possess nuclear forces capable of playing a deterrent role of their own contributing to the overall strengthening of the deterrence of the Alliance.7⁽¹⁾
